**NOTICE OF APPLICATION TO MAKE A NON MATERIAL CHANGE TO THE FOLLOWING DEVELOPMENT CONSENT ORDER:**

**THE HIRWAUN GENERATING STATION ORDER 2015 (SI 2015/1574) AS CORRECTED BY THE HIRWAUN GENERATING STATION (CORRECTION) ORDER 2015 (SI 2015/0000)**

Notice is hereby given that an application has been made by Hirwaun Power Limited ("HPL") of 33 Cavendish Square, London, W1G 0PW to the Secretary of State for Business, Energy and Industrial Strategy to make a non-material change to the Hirwaun Generating Station Order 2015 (as corrected by the Hirwaun Generating Station (Correction) Order 2015) ("the Order") under the Planning Act 2008 ("the Application").

The Order grants development consent for the construction, operation and maintenance of a generating station comprising of between one and five gas turbine generators. The Application seeks to make the following non material amendment to the Order in order to construct the generating station with one gas turbine:

1. Amend the permitted length of the Gas Turbine Generator (GTG) from a maximum of 30 metres to 50 metres to accommodate the diffuser system elements and to amend the permitted width from a maximum of 30 metres to 40 metres to accommodate the lube oil system;
2. Amend the permitted width of the lower section of the flue stack from 10 metres to 11 metres up to a height of 16.5 metres;
3. Amend the permitted number of black start diesel generators from one to three in Work No 2B;
4. The inclusion of external fin fan coolers with a maximum height of 6 metres, a maximum width of 10 metres and a maximum length of 13 metres in Work No 2E; and
5. Amend the area for Work No 2C on the Works Plans in order to construct the switchyard closer to the GTG.

The Application also seeks to make the following non material amendment to the Order in order to construct the generating station with between one and five gas turbines;

1. Amend the permitted length of the black start diesel generator from 13 metres to 17 metres; and
2. Amend the permitted natural gas receiving compound and gas treatment compound so as to permit the construction of two separate smaller compounds.
